



EXCHANGE APPLICATION SEASIDE AND SOUTH SHORE FRACTIONAL RESORT WEEK(S)

Resort at Seaside and Resort at South Shore fractional week Owners have the ability through an exchange program known as The Exchange Network (TEN) offered by Wyndham Resort Development Corporation (WRDC) doing business as WorldMark by Wyndham (WBW) to deposit their fractional week(s) with TEN in exchange for Trade Credits for use of available WorldMark accommodations.

The continuation of this program is dependant upon the continuation of the affiliation relationship between TEN and the association where the fractional interest resort week is located. This benefit may also be modified or terminated at any time without prior notice; except that weeks accepted before such modification or termination will be honored under the terms and conditions in effect when the week(s) were accepted.

MEMBER IN GOOD STANDING

- Member must be an Owner in good standing with the Fractional Resort affiliated with TEN and WRDC. All fees and assessments must be current at the time of application.
- Charges and assessments on the Fractional Interest Week shall be the responsibility of the Owner and shall be kept current.

FRACTIONAL INTEREST WEEK(S)

- Only whole fractional weeks may be deposited.
- The arrival date (occupancy period) of the week being deposited must be more than 45 days but not more than one (1) year from the date of this application.
- Any week(s) exchanged by this application are for the dates on this application only. Future exchanges will be accepted only by executing a new exchange program application.
- Fractional Interest Week(s) must be registered in Owners name and resort must be currently affiliated with TEN.

TRADE CREDITS

- Trade Credits issued by this program are one-time use only credits.
- Trade Credits may be combined with other vacation credits and used to request reservations within TEN at WorldMark resorts, and for reservations at other resorts and benefits as permitted by WBW.
- The number of Trade Credits issued is based on the size and season of the week being deposited and is in accordance with the grid shown on the reverse side of this form.
- Where the week being deposited crosses between two seasons Trade Credits equivalent to their actual value (e.g. 3 days in red, 4 days in white) will be issued.
- Trade Credits must be booked within one (1) year from the date they are deposited into the Member's account.
- Any reservations subsequently cancelled are subject to the Affiliate Resort guidelines and Trade Credits may be forfeited.

ASSURANCE OF AVAILABILITY

- Owner shall not withdraw or trade the Fractional Interest Week to another entity for the period it has been committed to TEN. If the week is sold after the application has been accepted, Owner must disclose to the purchaser that purchaser does not have the right to occupy the week during the time period it has been committed under this program, and the sale shall be subject to this program.

TRANSACTION FEE

- There is a \$35.00 non-refundable processing fee for each week exchanged, and payment must accompany this application. If the exchange request is denied for any reason, the fee will be returned. The fee is subject to change at any time without notice.

HOUSEKEEPING FEE

- Owner shall receive one free housekeeping credit for each qualified week accepted for exchange.
